UNCOMPANIED BAGGAGE SHIPMENTS OF WINE IN USA

This service enhancement will allow US residents to purchase wine abroad in selected and approved shops which will ship it back to their home address as “unaccompanied baggage”. Wine only for unaccompanied baggage wine shipments to 27 acceptable states and the District of Columbia (D.C.) outlined below. No B2C for beer or liquor (Spirits).

The quantity limits for each unaccompanied baggage wine shipment is listed for each approved state below

<i>Alaska AK: No quantity limitation</i>	<i>Missouri: 18 liters</i>
<i>Arizona AZ: 1 liter</i>	<i>Nevada: No quantity limitation</i>
<i>Colorado CO: No quantity limitation</i>	<i>New Hampshire: 2.8 liters</i>
<i>Connecticut CT: 18 liters</i>	<i>New Mexico: No quantity limitation</i>
<i>Delaware: 9 liters</i>	<i>New York NY: No quantity limitation</i>

Unaccompanied baggage shipments of wine are not accepted to: Alabama, Arkansas, California, Idaho, Kansas, Kentucky, Maryland, Massachusetts, Minnesota, Mississippi, Montana, Nebraska, New Jersey, Oregon, South Carolina, South Dakota, Texas, Utah, Vermont, Virginia, West Virginia, Wisconsin, and Wyoming.

The wine cannot exceed alcoholic content of 12%, to be imported in USA.

The consignee should fill and sign the attached declaration, in order to prove that they have visited our winery prior their order. This declaration is obligatory by US customs regulation.
